The Owner agrees:

I understand the educational purposes of canine training, and in consideration of being allowed to participate in the training classes being provided by Twin Cedar K9 ("Trainer"), hereby agree on behalf of myself, my spouse, heirs, legal representatives, assigns, guests, invitees and my insurer, as follows:

- 1. I am fully aware and acknowledge that canine training can cause stress in dogs and that the training may be done in the presence of other persons and animals; I am fully aware of the risks and dangers involved, and hereby accept full responsibility for any and all risks of bodily injury to myself, my dog, or to any other person and/or animal which results from my attendance and participation in such training.
- 2. I am also fully aware and acknowledge that training may include the use of training aids such as training collars, prong (pinch) collars and shock collars, and that if such training aid is to be used, the manner and procedure will be discussed with me and informal consent obtained prior to the use of such training aid.
- 3. I hereby agree to hold Twin Cedar K9, the individual trainers and assistants, relations thereto, sponsors of the training, owners of the premises upon which the training is being held and their employees and guests (including other dog owners) harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of the Dog while in or upon the training premises or grounds or near any entrance thereto, and I personally assume all responsibility and liability for any such claim.

- 4. I further agree to hold the aforementioned parties harmless from any claim for loss of the Dog by disappearance, theft, damage or injury, be it caused or alleged to be caused by the negligence of the aforementioned parties, or by the negligence of any other person, or any other cause or causes.
- I assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself or on account of damage to property, arising out of or in consequence of my participation in this training, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
- 6. I agree that the Dog may participate in group socialization with other dogs. I am aware of the risks and dangers involved and accept full responsibility for any and all risks of bodily injury to myself, the Dog or to any other person and/or animal which results from such activity/training.
- 7. I agreed that Twin Cedar K9 or the trainers have the right to refuse this registration or excuse the Dog from class for any cause which they in their sole discretion shall deem to be sufficient.
- 8. Furthermore, by signing my name below, I acknowledge and accept the foregoing paragraphs and agree to follow any rules and directions of Twin Cedar K9, its owners, employees or agents.
- 9. Cancellation Policy: Twin Cedar K9 requires 24 hours notice of cancellation of appointments. If at least 24 hours notice is not given and the appointment cannot be rescheduled with another client, I understand and agree that Twin Cedar K9 will bill me at the normal hourly rate for my missed appointment.
- 10. I acknowledge that Trainer has promised no particular result in the behavior/training of the Dog. Trainer makes no guarantee as to the outcome of the training including but not limited to whether the dog will bite or continue to have any dangerous propensity.
